


Local partnerships enable us to

- Ambassadors


Currently stimulation through:

Conclusion

- Social innovation and experimentation are critical for finding new solutions to complex societal problems.
- They allow us to test new ideas before investing significant resources in them.
- However, there are many challenges associated with these approaches, but at the same time it offers a lot of potential.
- To be successful in this field, it's important to have certain competencies.
- We have to learn to make an opportunity out of every problem.
- Need for clear definition of problems extensive stakeholder analysis.
- All partners need a clear role and well-defined responsibility.


